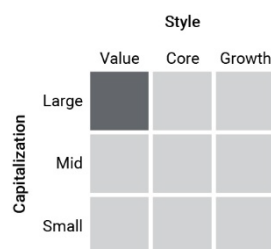


Brandes U.S. Value ETF (BUSA)

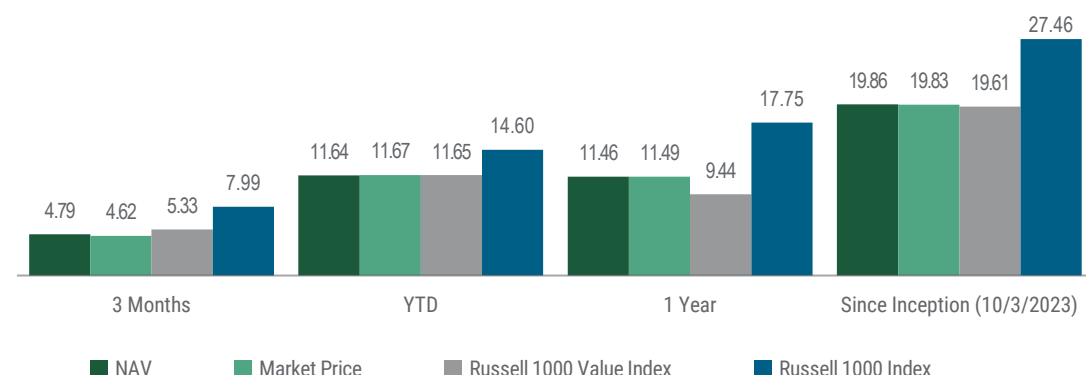
