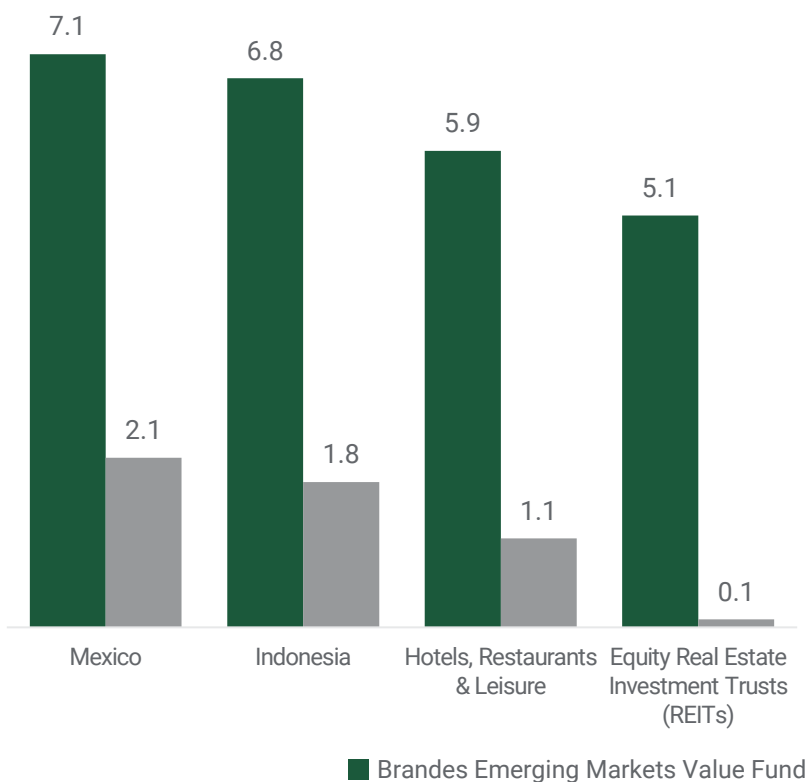

Select Differentials vs. Benchmark

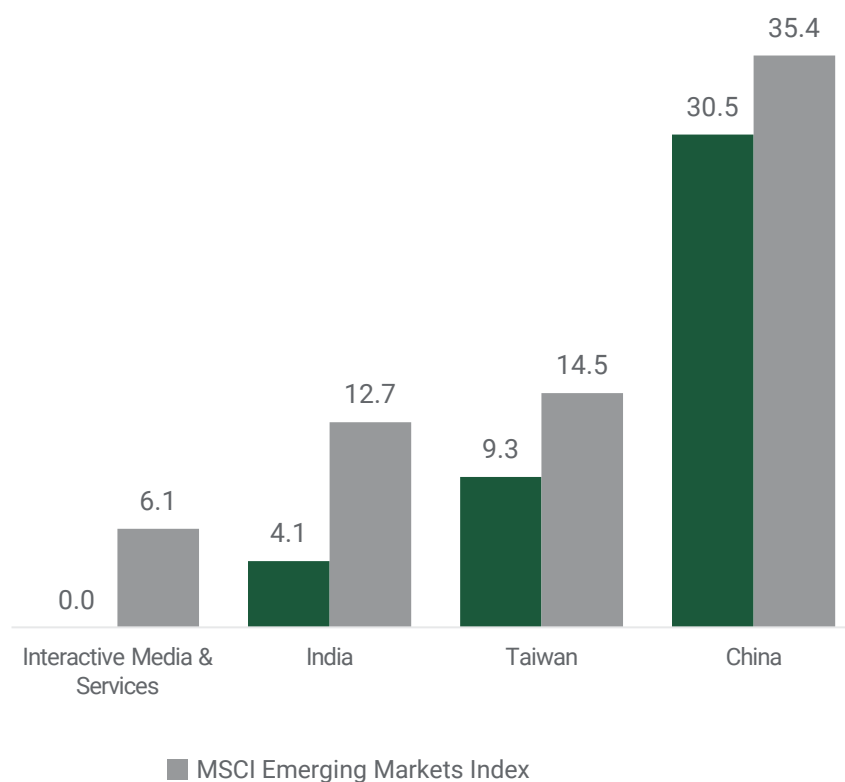

% of Fund



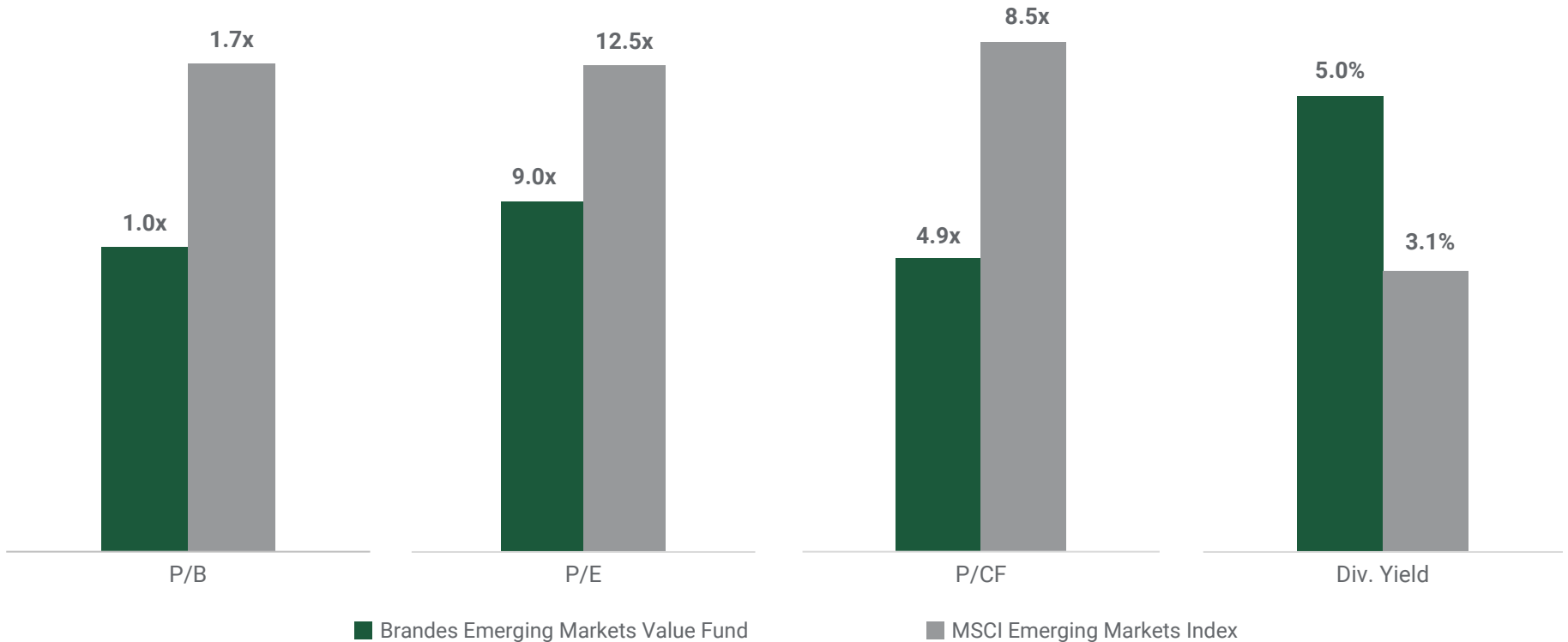
Key Underweights

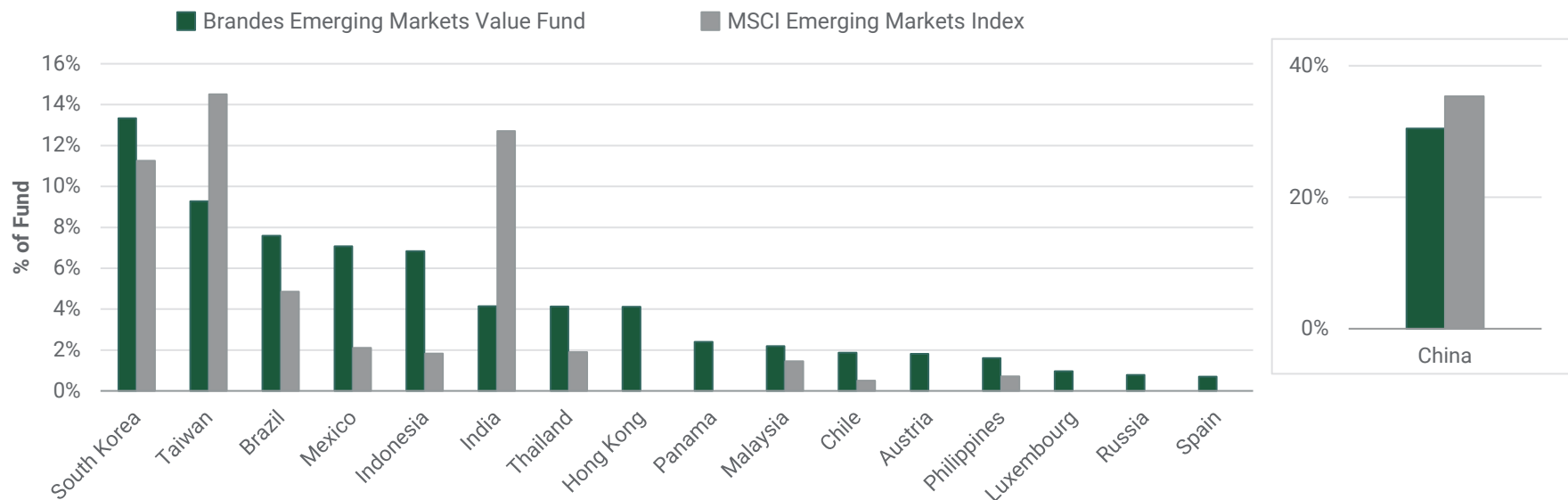

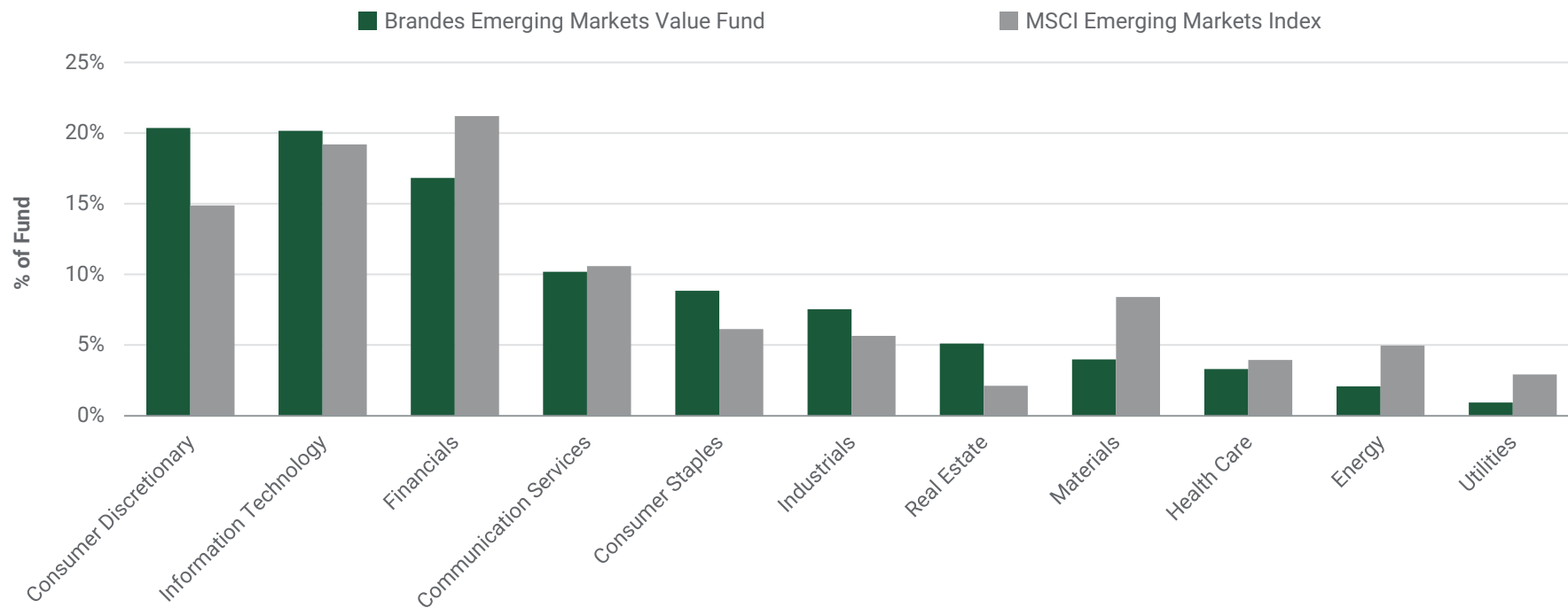

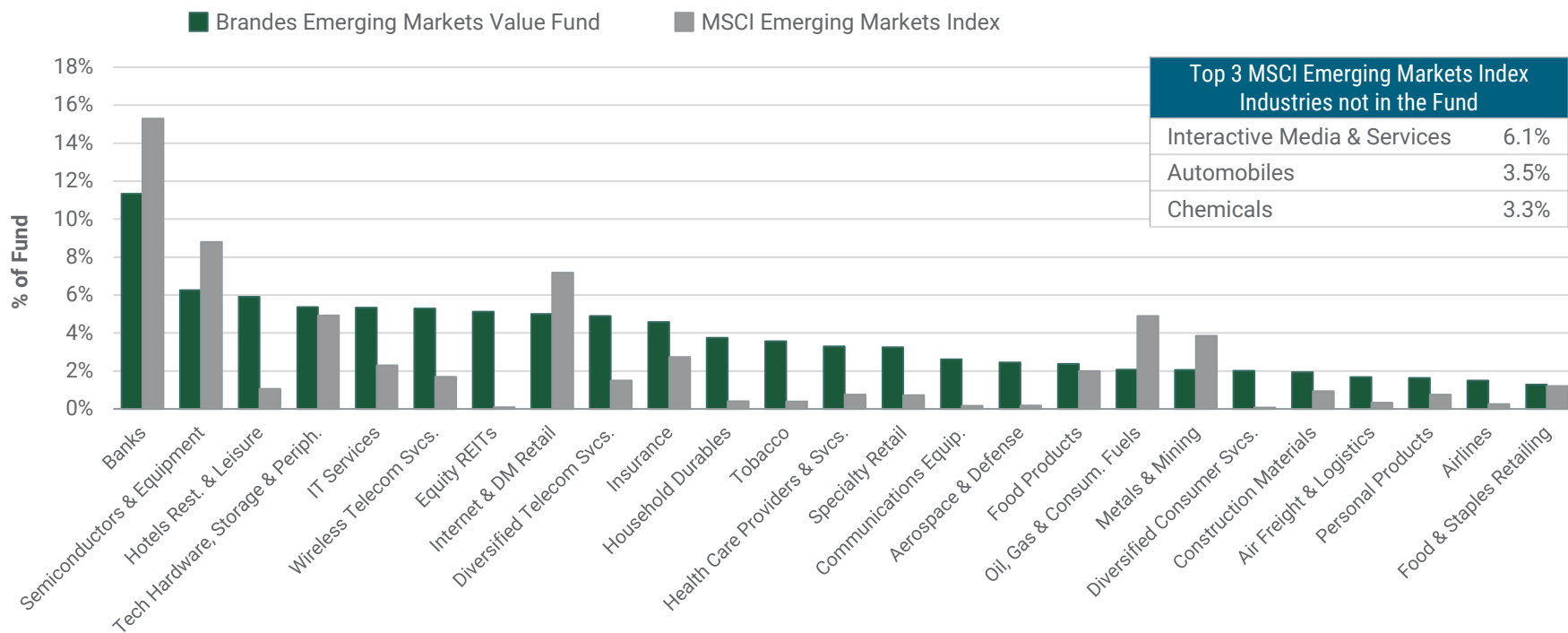

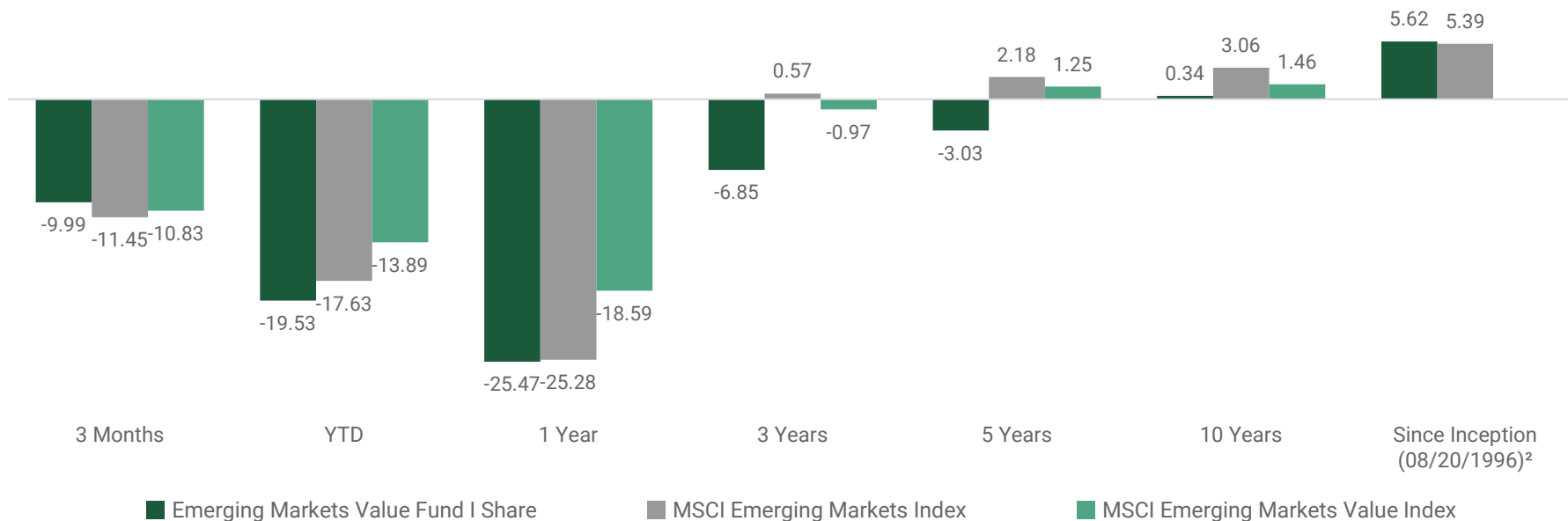
