

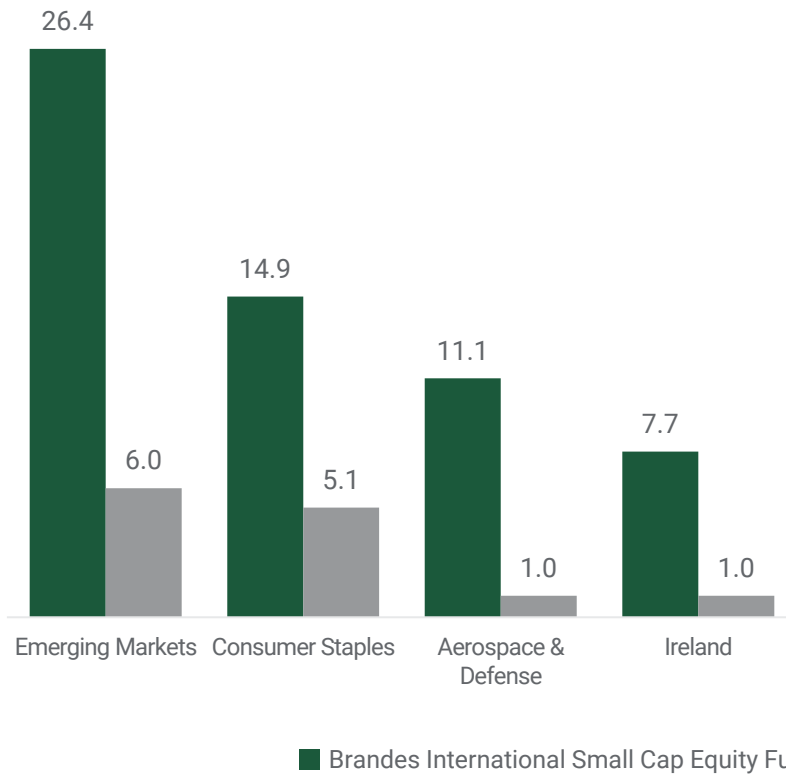

# Select Differentials vs. Benchmark

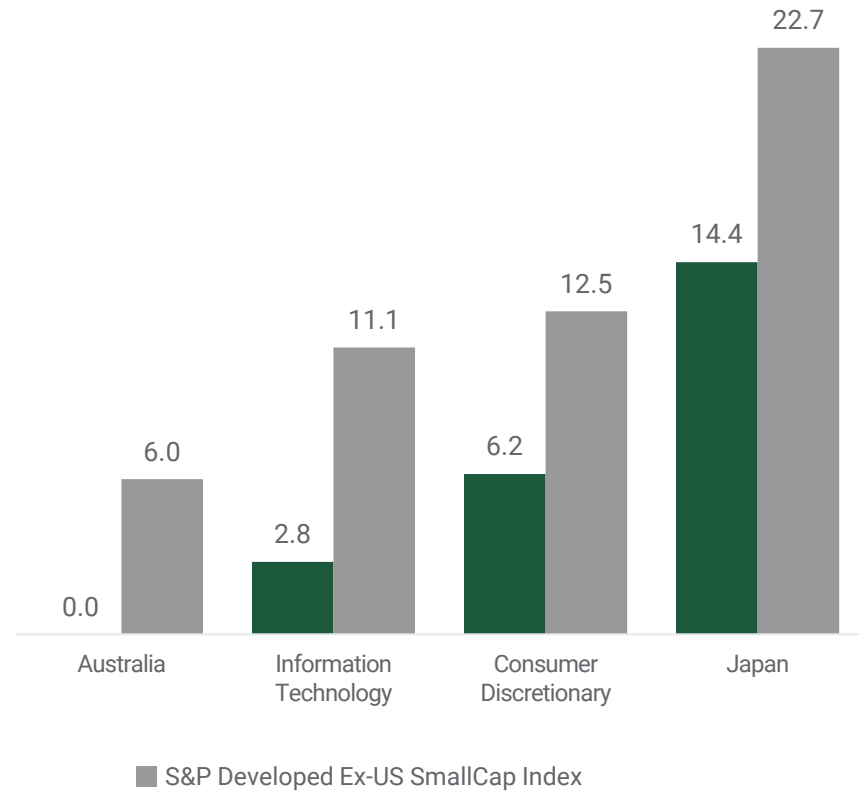
## Key Overweights

% of Fund



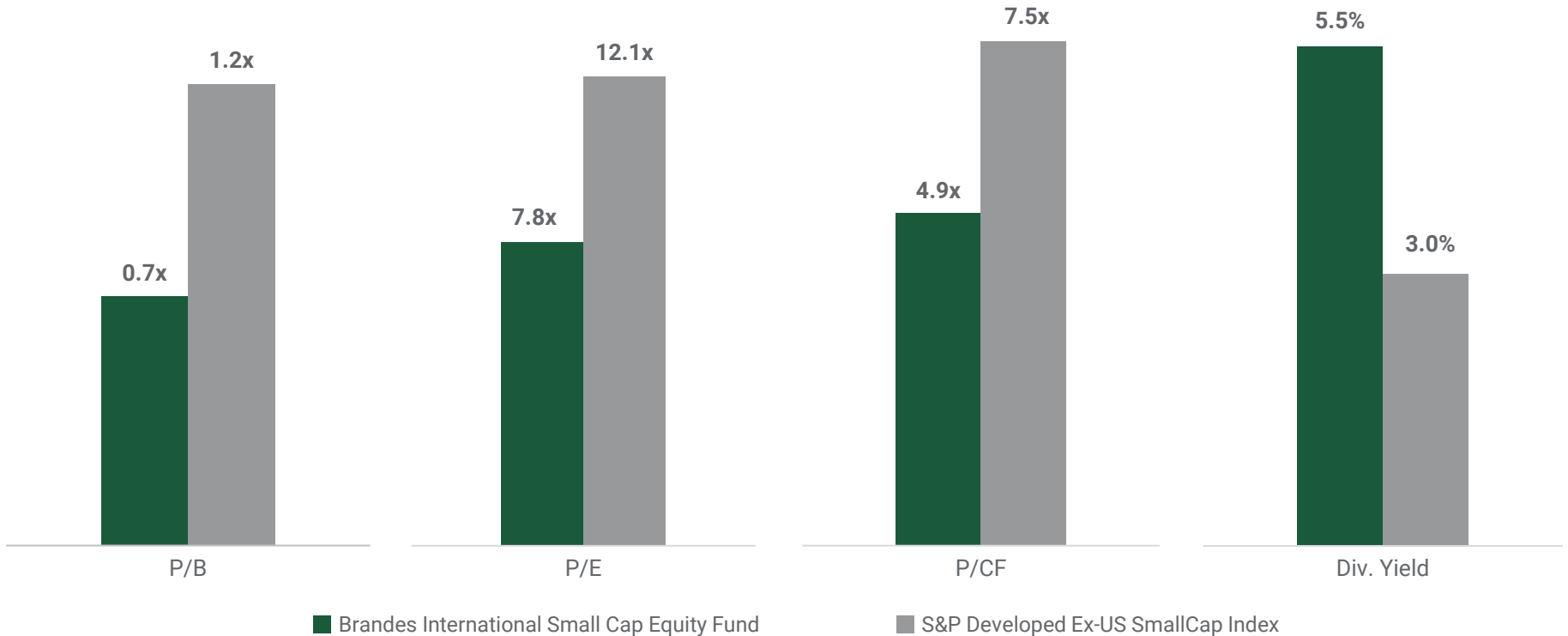
## Key Underweights

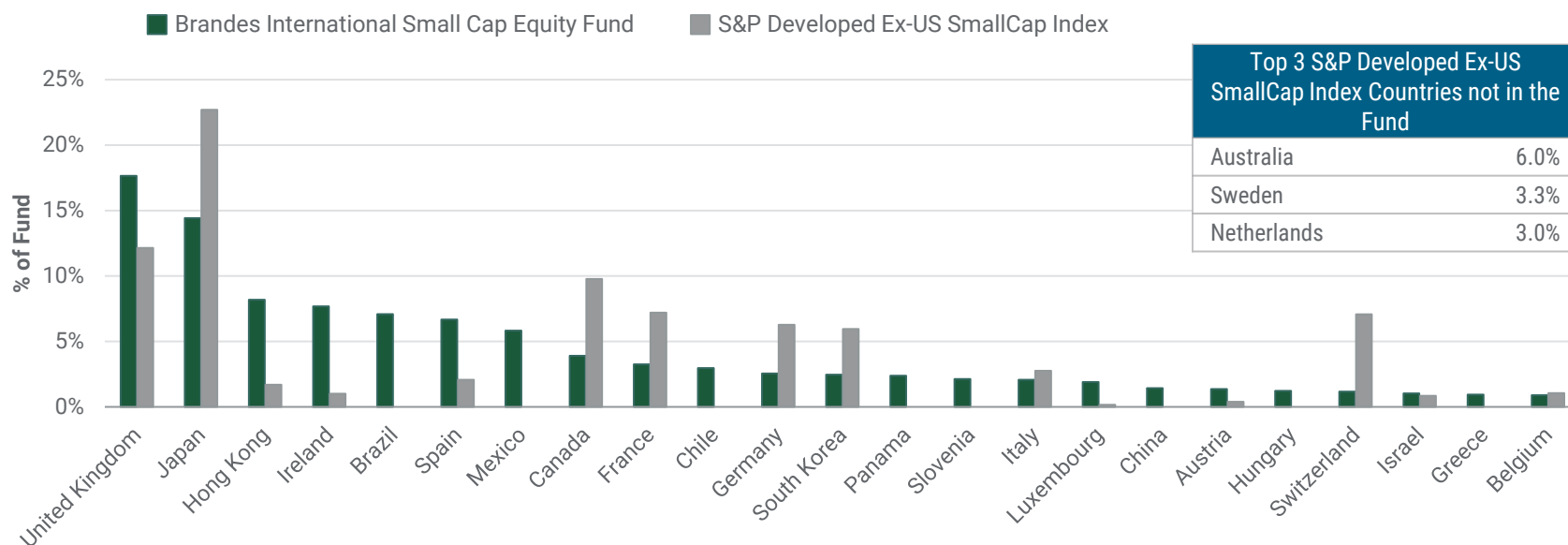

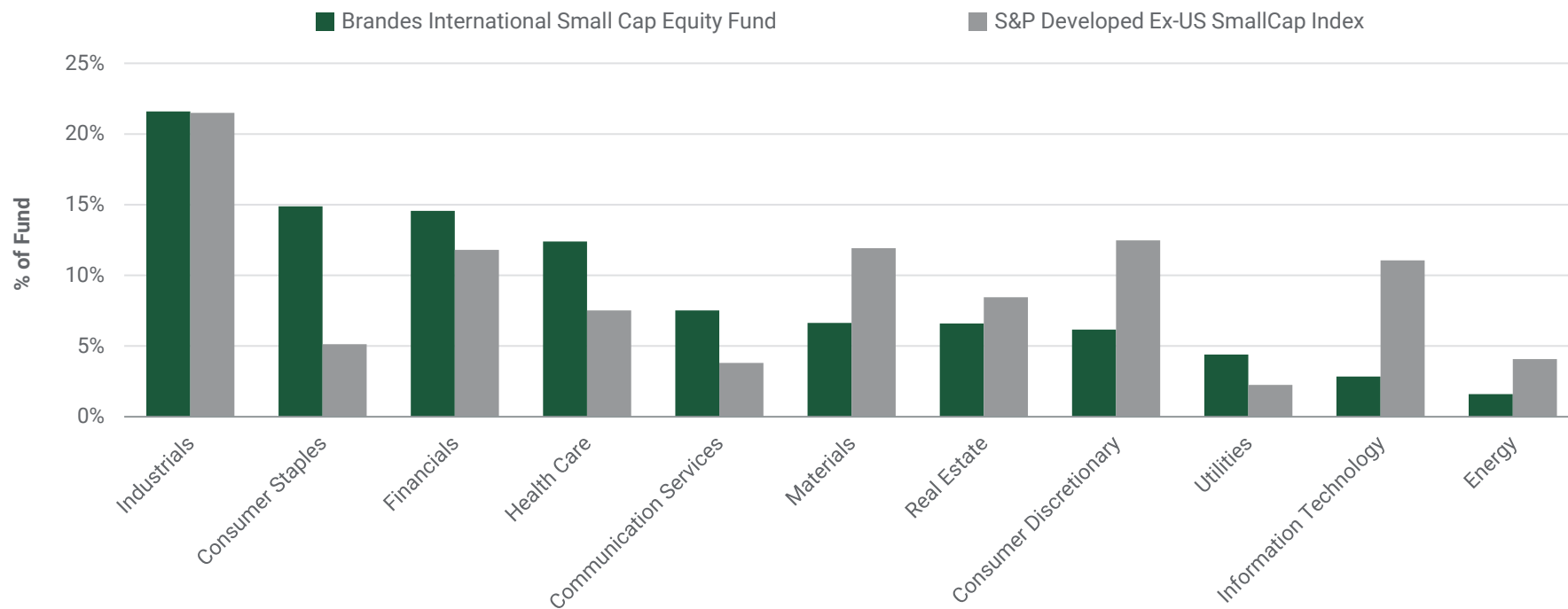

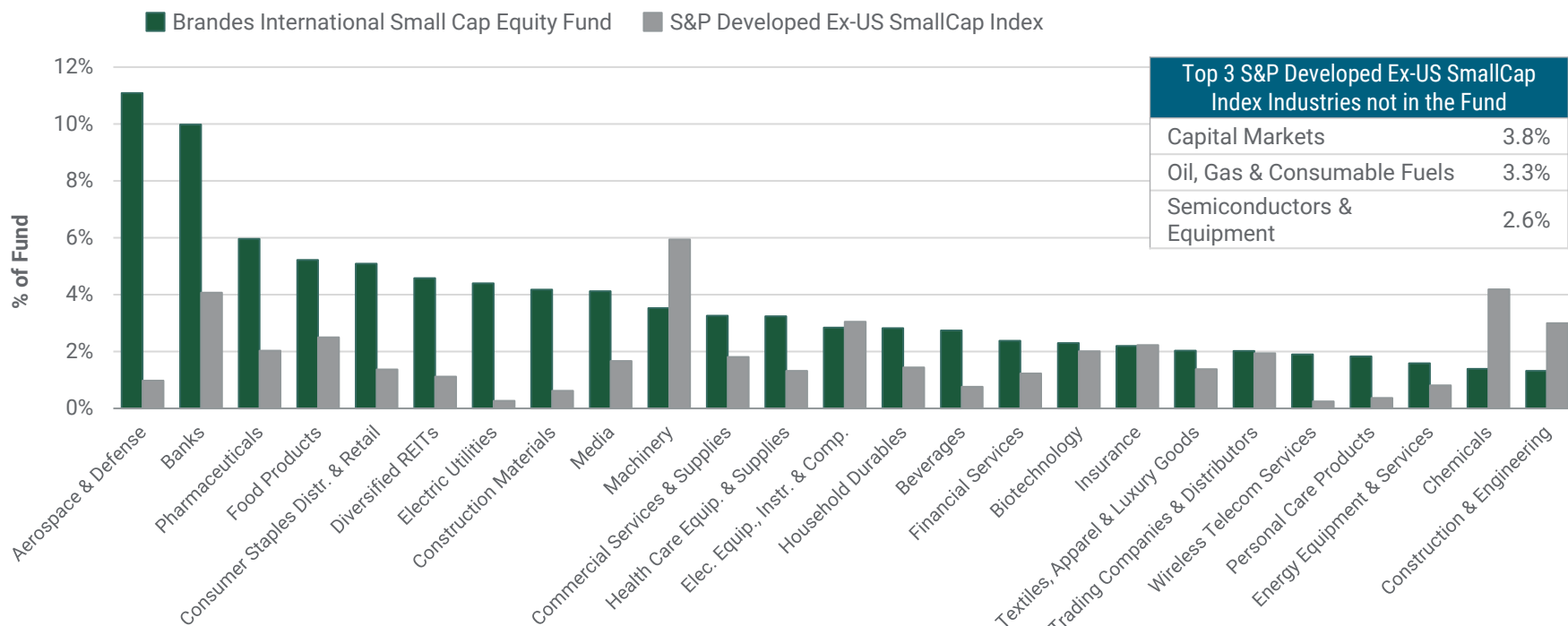

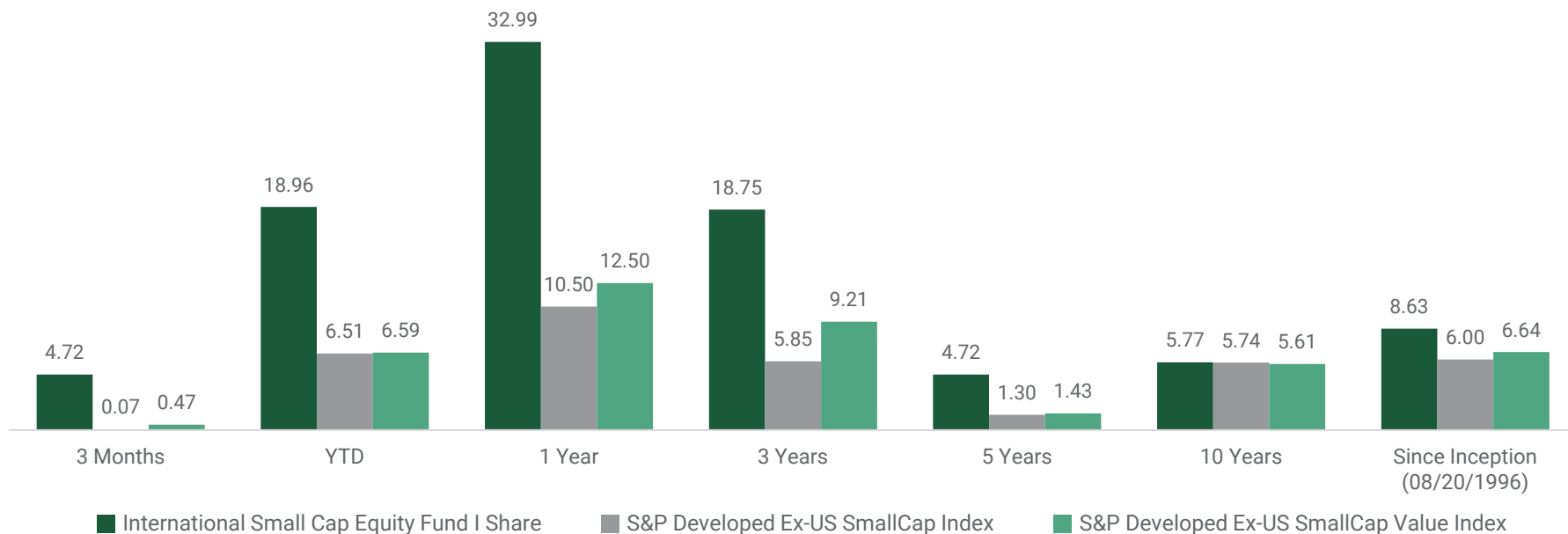
