

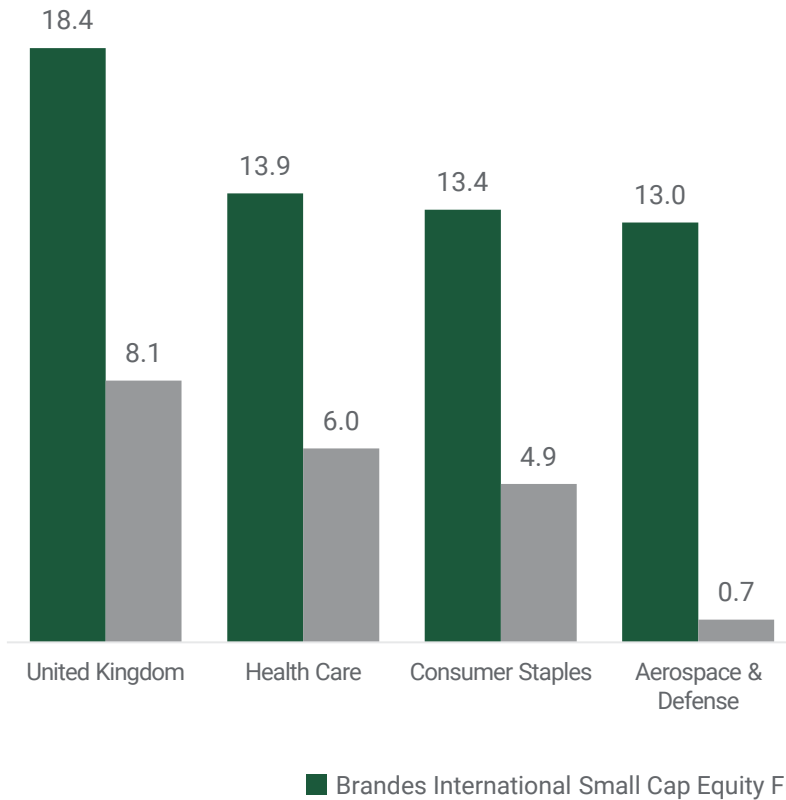

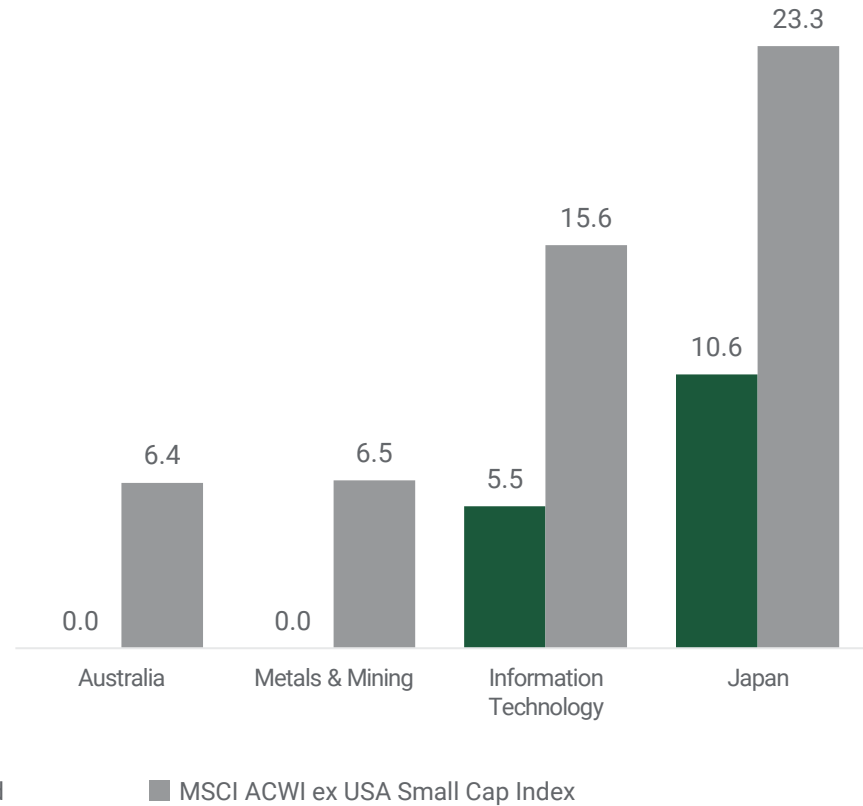
Key Overweights

% of Fund



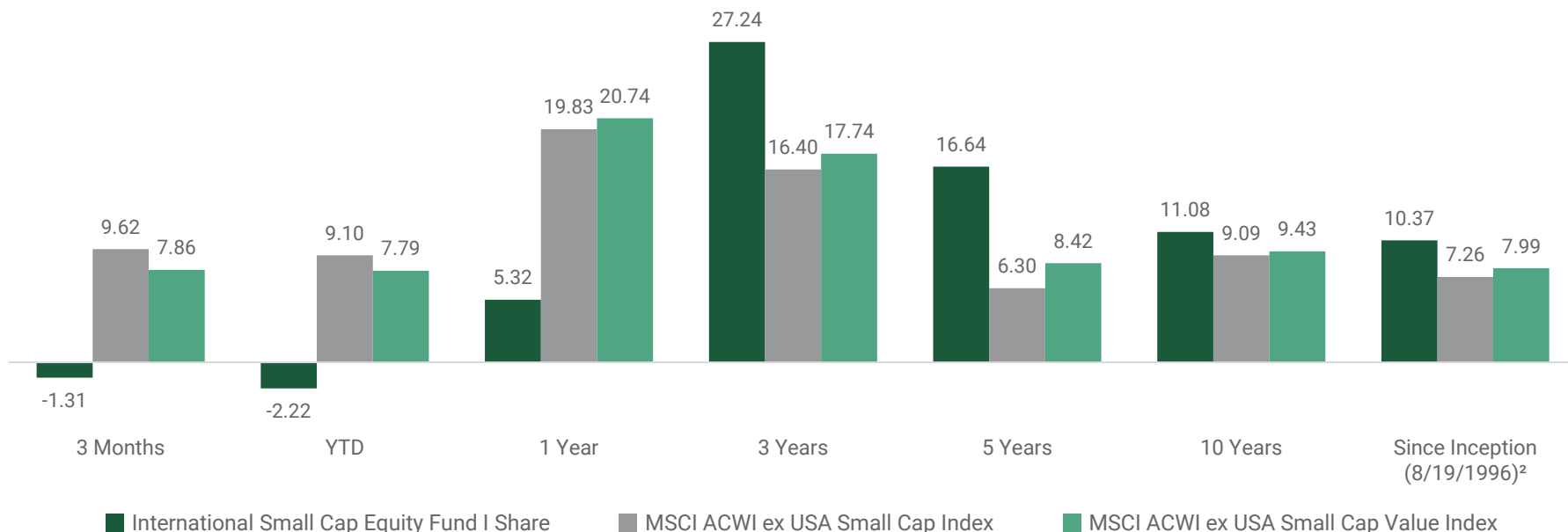
Key Underweights

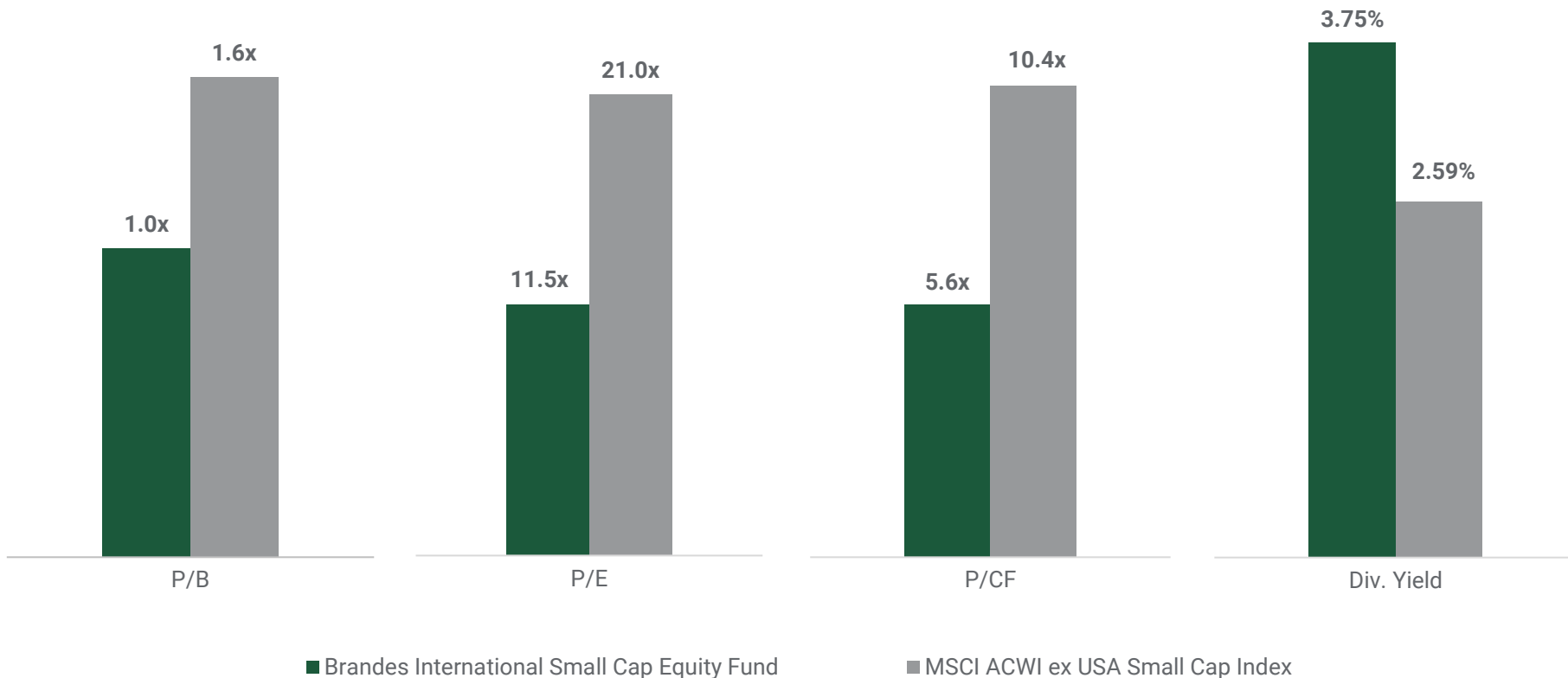

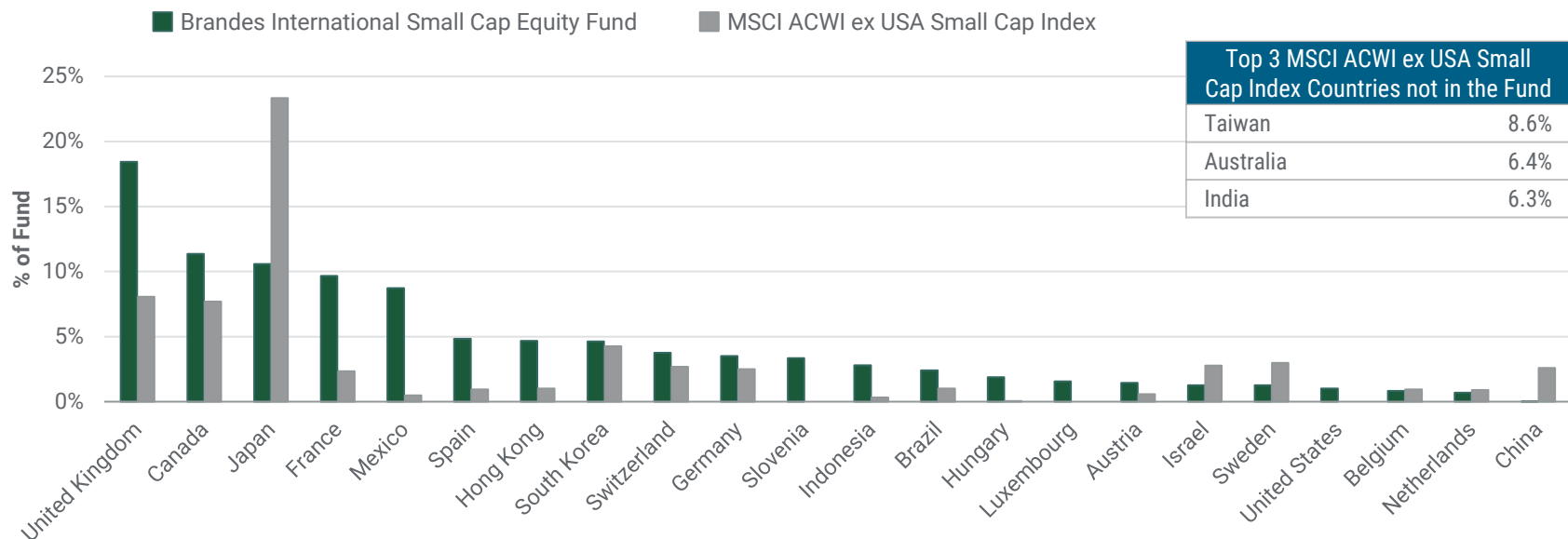

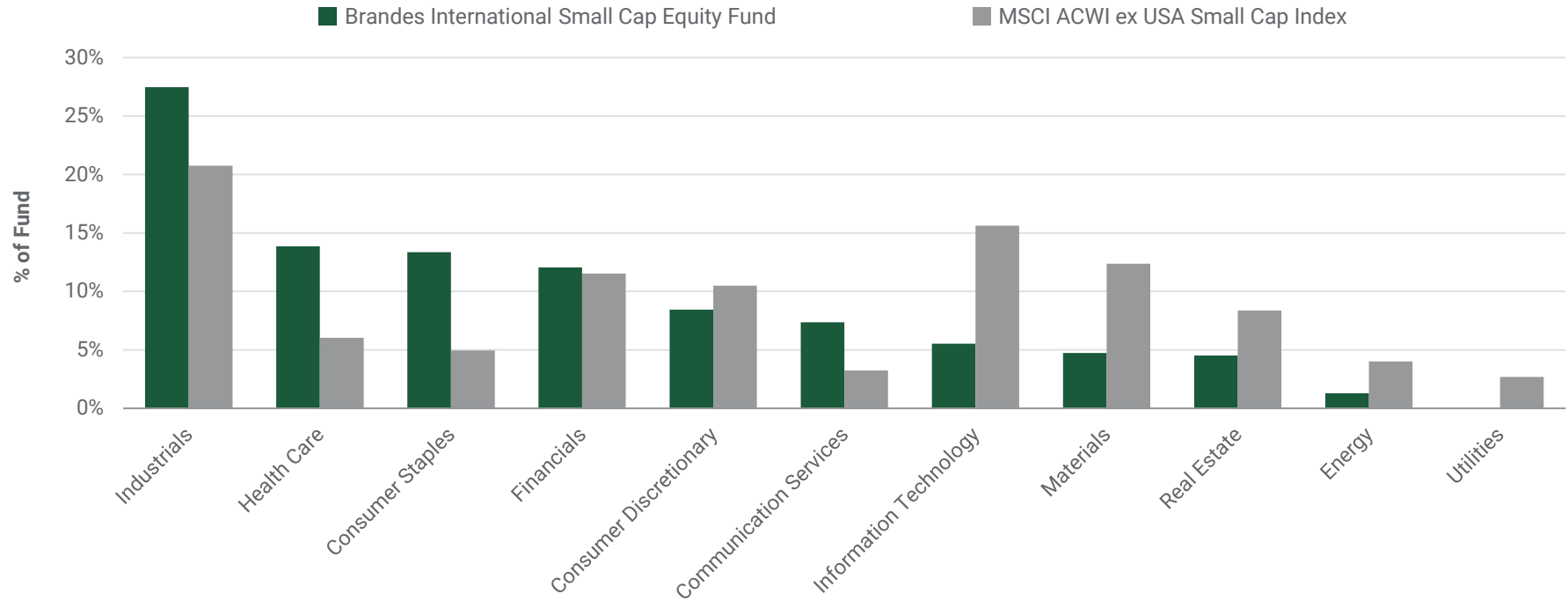

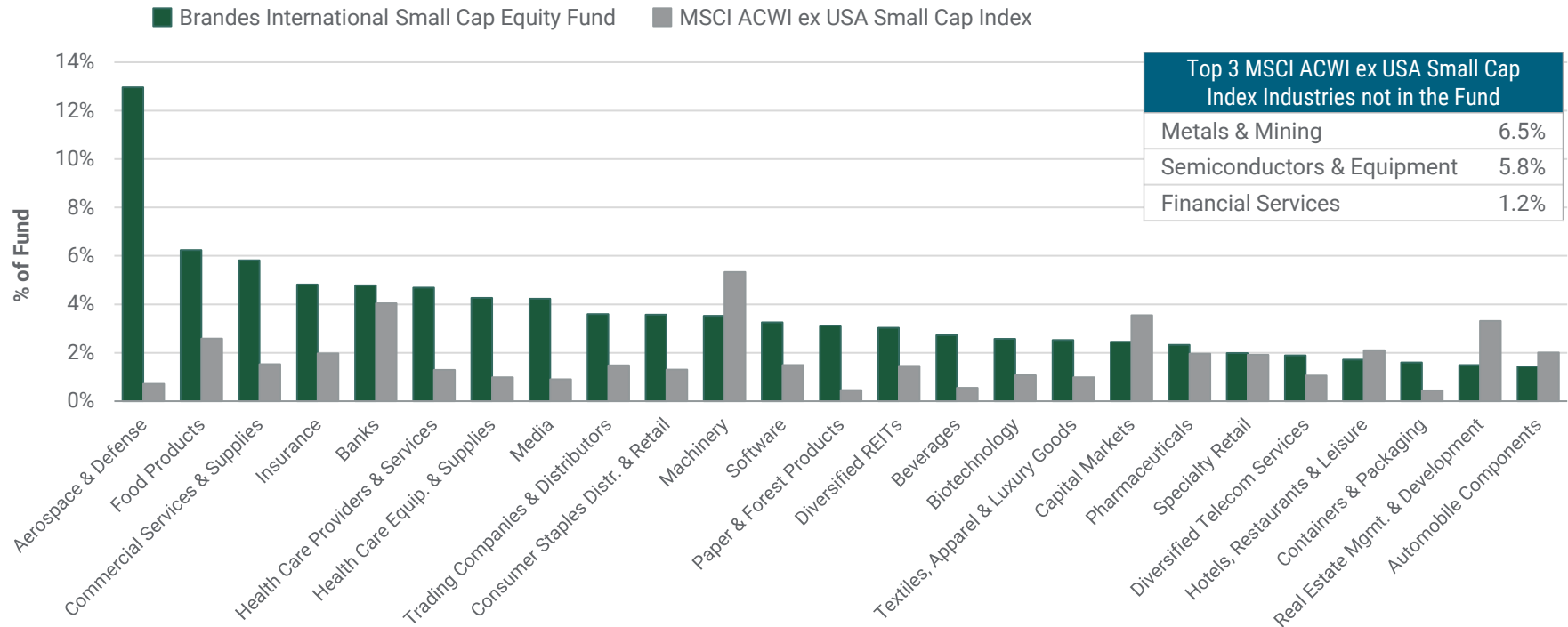
