





While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. Brandes European Value Fund was rated against the following numbers of Europe Large-Cap Value Equity funds over the following time periods: 273 funds in the last three years, 246 funds in the last five years, and 158 funds in the last ten years.
