

Morningstar Style Box™




The Morningstar Style Box™ reveals a fund's investment strategy by showing its investment style and market capitalization based on the fund's portfolio holdings.



While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. Brandes Global Value Fund was rated against the following numbers of Global Large-Cap Value Equity funds over the following time periods: 591 funds in the last three years, 457 funds in the last five years, and 338 funds in the last ten years.
